State of Democracy in India











INTERNET AND PRESS FREEDOM

- Between 2021 and 2022, India dropped 8 ranks in the
 Reporters Without Borders Press Freedom Index, to rank
 150th worst world-wide.
- The 2023 <u>report</u> by Access Now and the #KeepltOn coalition documented <u>India</u> as the world leader of Internet shutdowns for the fifth consecutive year. Data from the <u>Software Freedom Law Center</u> shows that most of its shutdowns have been preventive in nature. Takedown orders by the Indian government <u>increased by 11%</u> between 2021 and 2022. The <u>552-day</u> shutdown in <u>Kashmir</u> constitutes the longest internet shutdown in a democratic country.
- Between 2010-2020, <u>154 journalists</u> were arrested, detained, interrogated, or harassed for their work. Over 40% of incidents took place in <u>2020 itself</u>. The government has imposed <u>travel bans</u> on over 22 journalists, several of whom have faced raids, threats, and detention. Independent media, including the BBC, have faced <u>raids</u> or temporary <u>suspension</u> after coverage critical of the government.

DEMOCRATIC INSTITUTIONS

- In January 2023, former senior Supreme Court judges warned that oversight bodies had been "turned into extended arms of the central government" and had been "ignoring the Constitution of India".
- Research by <u>Article14 from 2022</u> notes that for 1.5 years, there was **no progress on six cases of national importance** in the Supreme Court, and 53 cases that required a wider review by a constitution bench were kept pending.
- Since July 2022, the ruling BJP does not have Muslim representatives in either of the two houses of Parliament or state assemblies.

RISK FACTORS FOR MASS ATROCITIES

- The <u>Early Warning Project in 2023</u> ranks India 8th highestrisk of concern for mass atrocities against religious minorities among 162 countries.
- Targeted violence on grounds of protected characteristics disproportionately targets religious minorities. Of over 19014 verified victims of communal violence, physical assaults, and lynching since 2017 (status: August 2022), the majority (86.7%) are Muslims. Violence against Christians also rose by 81% between 2020 and 2021. More than 2000 Christians were attacked and injured in the first nine months of 2021.
- Elected legislators and ministers engage in hate speech and legitimation of violence against religious minorities. Examples include BJP MP Pragya Thakur (2022) urging attendees of a conference to "keep knives sharpened", BJP Government Minister of State for Finance Anurag Thakur (2020) calling to "shoot the traitors of the country", which triggered communal violence in which at least 53 people died, and India's BJP Home Minister Amit Shah (2019) calling Rohingya refugees "termites".

CIVIL SOCIETY AND CIVIC SPACES

- In 2020, Freedom House's <u>Freedom in the World report</u> downgraded India to "party free" and ranked India as one of the 'Countries in the Spotlight' for the "deterioration of basic freedoms". The V-Dem Institute has considered India an "<u>electoral autocracy</u>" for several years in a row. The V-Dem Institute considers India one of the "<u>worst autocratizers in the last 10 years</u>".
- Between 2015 and 2018, there was a decline of 40 per cent in funding to NGOs in India following amendments to the Foreign Contribution (Regulation) Act (FCRA). Amnesty India was forced to suspend its operations in India in 2020 after the government froze the organization's bank accounts for alleged FCRA violations.
- Human rights defenders and civil society are systematically
 persecuted and evidence <u>planted</u>. For example, in July 2021, 84year-old Jesuit priest Father Stan Swamy <u>died in custody</u> while
 imprisoned without trial under sedition laws and being denied
 medical care.
- In 2019, the Unlawful Activities (Prevention) Act (UAPA) was amended to allow the <u>executive power to designate individuals as terrorists</u> without due process.

EXCLUSION FROM CITIZENRY

- In the state of Assam, a process to identify "citizens" of India left
 1.9 million persons de facto stateless. Home Minister Amit Shah
 announced that a National Registry of Citizens (NRC) would be
 conducted for the whole of India.
- In 2019, India enacted Citizenship Amendment Act (CAA) to grant citizenship on basis of religious identity. The Act excludes Muslims. The NRC coupled with the CAA risks mass statelessness of Muslims throughout the country. The OHCHR called the amendment 'fundamentally discriminatory', as it adds a religious criterion to citizenship.

CRIMINALISING PROTEST AND EXTRAJUDICIAL REPRISALS

- In February 2022, <u>Prime Minister Narendra Modi</u> described people participating in various peaceful protests as "**parasites**."
- <u>96% of sedition cases</u> after 2014 have been filed against citizens criticizing the government and politicians.
- Several BJP-led states in India have demolished homes with bulldozers without due process, reportedly as reprisal for participation in anti-government protests.
- In 2020, the Uttar Pradesh in violation of privacy rights <u>put up public billboards</u> displaying names, photos, and residential addresses of people who had participated in protests against the CAA, a discriminatory law. It then passed the <u>Recovery of Damages to Public and Private Property Ordinance</u>, which enabled recovery for damages allegedly caused during protests the accused participated in without proving they personally contributed to the damages.
- The Bihar and Uttarakhand police in 2021 issued <u>circulars</u> <u>threatening individuals participating in protests</u> with obstacles to getting passports, government jobs, financial grants and bank loans, and started monitoring social media for "<u>objectionable</u>" comments against the State government.
